Constitution

Article 1-Name

The name of the organization shall be the "Lake George Warriors Booster Club, Inc.".

Article II-Purpose

The purpose of our Club is to support and service the Lake George Interscholastic Athletic programs. The Club will support our entire collection of both the boys and girls LG interscholastic athletic teams. The organization is interested in developing a following for the athletic teams and providing encouragement, rewards, and honors for participation in athletics. The funds will offset any areas not currently funded by our Lake George Interscholastic Athletic Budget. These items may include but are not limited to Championship Banquets and/or Awards, Senior Banquet, special equipment needs, and other unexpected expenses that may arise.

Article III-Membership

Any person may be a member of the organization provided they pay a membership fee established by the Board of Directors and approved by membership. To remain in good standing, members must represent Lake George Schools in a positive manner and promote and encourage our student athletes and all the athletic programs of Lake George School.

Article IV

The administrative control of the Lake George Warriors Booster Club shall be vested in a Board of Directors which shall include the elected officers of the organization. The elected officers shall be president, vice president, a secretary, and a treasurer. The method of election of the officers and the directors shall be specified in the Bylaws of the organization.

Article V-Meetings

The LGWBC shall hold meetings monthly. More meetings will be scheduled as necessary to conduct general business of the organization.

Article VI-Amendments

Amendments to this Constitution may be adopted by a 2/3 vote of active membership.

Bylaws

1. - Due

The annual dues for active membership shall be based on a scheduled approved by the board of directors. Membership eligibility shall be for the fiscal year-January 1-December 31..

2. -Election of Officers

Election of officers shall take place in June every year by a mail in ballot. Terms of all offices will be one year.

3. Duties of officers

The president shall be the chief executive officer of the organization and shall serve a one year term. He shall preside over all business meetings, including meetings of the board of Directors and perform such other duties as would be expected of the presidency. He shall have the power to appoint and be an exoffico member of all committees and call meetings of such committee when in his judgment the interest of the organization warrants. A vacancy in the office of president shall be filled by the vice president. A vacancy in another office may be filled by an appointee of the president until the general election occurs.

4. Vice President

The Vice president will serve as president when the president is unavailable and is a voting member of the board of directors.

5. Secretary

The secretary will be responsible for taking minutes at all meetings and forward minutes in a timely manner to board members for approval. The secretary shall be responsible for maintaining files of minutes as well as membership information not limited to address, e mail address, and telephone numbers.

6. Treasurer

The treasurer shall be the chief financial officer of the organization. He will be responsible for maintaining the finances of the organization and preparing reports pertaining to income and expenditures of the organization. He shall also be responsible for preparing all reports required by outside entities for the organization to maintain its standing.

7. Directors at Large

Three persons will serve as directors at large. Directors shall be responsible for attending all necessary meetings and will have full voting privileges.

8. Expenditures-

All Expenditures of the organization must be approved by a majority vote of the Board of directors. A minimum of 6 Members of the Board of Directors must be present for expenditures to be approved.

9. Meeting Rules-

Robert's Rules of Order shall determine procedures to be used at all meetings.

10. Fiscal Year

The Fiscal year of the organization shall begin on Jan 1 of each year and end on December 31.

11. Changes to by laws.

By laws may be changed by a majority vote of active membership.
