Our monitoring review, with New York State, has begun as of January 2024. We will be required to provide evidence to ensure programmatic, equitable services to private school, and fiscal compliance.

- Coronavirus Aid, Relief, and Economic Security Act (CARES Act) -
  - \$202,949
  - All money received and used for supplies and reopening after COVID shutdown
- Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA Act)
  - \$523,930
  - All money received and used towards HVAC project last summer
- American Rescue Plan Act (ARP Act/ESSER III)
  - \$1,177,516
  - At least \$235,504 must be spent towards remediation and learning loss
  - Money spent from July 1, 2021 September 30, 2024
  - Have until September 2024 to encumber all funds
  - HVAC Project and Supplies were majority of the purchases

As of 12/31/2023 \$215,473 of \$235,504 has been expended.
