### Overview

NYSED uses the process of Targeted Monitoring to review Local Education Agency (LEA's) for compliance with programmatic and fiscal requirements the following Education Stabilization Funds (ESF):

- Coronavirus Aid, Relief, and Economic Security Act (CARES Act) -
  - Elementary and Secondary School Emergency Relief Fund (ESSER I)
  - Governor's Emergency Education Relief Fund (GEERI)
- Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA Act)
  - Elementary and Secondary School Emergency Relief Fund (ESSER II)
  - Governor's Emergency Education Relief Fund (GEERII)
- American Rescue Plan Act (ARP Act)
  - Elementary and Secondary School Emergency Relief Fund (ESSER III)

Our monitoring review, with New York State, will begin January 2024. We will be required to provide evidence to ensure programmatic, equitable services to private school, and fiscal compliance.

## **2021-2022 Summary**

### JumpStart (Summer)

- 66% of participants remained at or above their their End Of Year (EOY) reading level in September.
- More than 80% of participants remained at or above their EOY i-ready benchmark measures.

### Sunrise Scholars (September - June)

- The median percent reading growth of participants was 188% on i-ready.
- The median percent math growth of participants was 123% on i-ready.

### High Dosage Tutoring (All year)

- 23 participants
- Subgroup (1/3 Students with Disabilities (SWD), 1/3 Economically disadvantaged, 1/2 moved into Lake George after 6th grade)
- Significant gains and regents success
