
Sanding, refinishing and restriping of the gymnasium floor is located at the Lake George Jr.-Sr. High School located at 381 Canada Street, Lake George, NY.


Please refer to the blueprints and project manual for specifications. You may request an electronic copy of each by emailing hartb@lkgeorge.org. All pricing to include the following: strip and sand gymnasium floor to remove all previous layers of existing floor finish plus all painted game lines, repaint floor striping and center court logo according to specs. Apply the proper number of layers of floor finish as required by the floor finish manufacturer to achieve proper finish, and proper disposal of all materials including sanding particles, empty containers, applicators and other items used in the process.

Work is to start **May 2, 2025** and is to be completed and usable no later than **June 2, 2025**. Any bid submitted will be binding for 60 days subsequent to the date of bid opening. The successful bidder will be required to provide a Certificate of Insurance for \$1 million dollars in liability coverage naming the Lake George Central School District as the additional insured and proof of Workers Compensation Insurance. The successful bidder must adhere to Prevailing Wage rates.

Product specifications must accompany the bid. It is the responsibility of the bidder to make all necessary measurements and calculations for the product needed. A pre-bid conference will be **December 2, 2024** at **8 AM** at the Jr.-Sr. High School. Bids must be submitted in sealed envelopes marked "**Gymnasium Floor Refinish - sealed bid**" and returned to the School District Business Office. Bids will be opened and read on **December 13, 2024** at **2:00 pm** in the District Business Office located at 381 Canada Street, Lake George, NY 12845.
